## 1.0 Introduction

This document provides information for the user pertaining to changes included in Pharmacy Point of Sale (ABSP) v1.0 p53. **Please be sure to distribute this addendum to your pharmacy billing staff prior to patch installation.** 

## 1.1 Summary of Changes

FID108610-Changes were made to the Pharmacy Point of Sale claim submission routines to re-enable connectivity to Change Healthcare for submitting and resubmitting claims, and to allow for releasing stranded claims in user-specified increments. Due to the urgency of this patch, these changes only apply to claim submissions. Sending and receiving patient eligibility checks via the ELIG and PRIV options will be addressed in the next ABSP patch. Using the TEST option to submit a test claim will also be addressed in the next ABSP patch.

## 2.0 Patch 53 Details

## 2.1 Claim Submission Protocol Update

Changes were made to the Pharmacy Point of Sale claim submission protocol to accommodate recent protocol changes implemented by Change Healthcare.

The claim submission protocol can be viewed in the ABSP Insurer file in the RX -DIAL OUT TO field. Prior to p53, this field was populated with ENVOY DIRECT VIA T1 LINE. Patch 53 will automatically update this field with HTTP POST for existing insurer entries.

Any new entries created in the ABSP Insurer file after the patch is installed will have to be manually updated to reflect the new protocol of HTTP POST. To do that, access the 'Advanced setup of insurer' option (POS > MGR > SET > INS > ADV), and enter the new insurer name. Populate the fields as you normally would. At the **RX-DIAL OUT TO** field, type 'HTTP POST' and press <enter>.

### 2.2 Submitting the Backlog

The claim submission protocol updates likely resulted in a large number of claims waiting to transmit. Rather than allow for having a potentially large number of claims transmit all at once and risk overloading the system, the patch installation process moves all of these claims into a deferred status bucket. This section provides instructions on how to transmit those claims to Change Healthcare. It's important to follow these instructions carefully.

Step 1: Check to make sure RPMS is communicating with Change Healthcare.

Access the 'Statistics & misc. options screen' in the Pharmacy POS Manager Menu (ABSP Manager Menu > MGR) and select the 'POK' option to Poke the queue. This should get the process running. If it's running, the numbers that are displayed will fluctuate and change.

Pay attention to the value displayed in the 'Wait for transmit' field. This is the number of claims that crossed into Pharmacy Point of Sale from the time the patch was installed to now and are being transmitted to Change Healthcare. This is not the number of claims that were placed into a deferred status. That will be explained later.

Use the U1 Action periodically to update and refresh the display. The number of claims in the 'Wait for transmit' field will decrease as claims are transmitted. When the number decreases to zero, proceed to step 2. It is important to wait until the number has decreased to zero before proceeding to step 2.

If the number of claims in the 'Wait for transmit' field increases substantially or doesn't look right, this is likely a display issue. Exit the MGR option and go back in.

If the MGR option appears to be stuck, refer to the Troubleshooting Tips section of the addendum.

Step 2: Submitting the backlog

As mentioned before, any claims that were in a status of 'waiting to transmit' prior to patch installation are now in a deferred status bucket. The deferred claims will have to be sent, or restored, in user-specified increments using a new option on the Pharmacy POS Manager Menu called REST Restore deferred claims from Optum Outage (p53) (MGR > MGR > REST).

Before starting the process, open two RPMS sessions. In one session, log into the MGR '**Statistics & misc. options screen**' so that you can keep an eye on the transmission progress as you submit each group of claims. In the other session, log into the new REST option. Position the two RPMS sessions side-by-side.

The following information will be displayed in the REST option: count of claims by deferred claim status code, count of claims submitted, and total number of claims that were deferred when the patch was installed.

The most commonly seen deferred claim statuses are:

- 10: Gathering info
- 19: Wait(ing for) packet build
- 50: Wait(ing) for transmit

To begin sending claims, enter a status number. Enter the number of claims to submit/restore. Keep an eye on the MGR 'Statistics & misc. options screen' to make sure the claims are being transmitted. When the 'Wait for Transmit' field reflects zero claims, go back into the REST option and submit another batch. Do not submit another batch of claims until the current batch has been transmitted.

Some important notes about the number of claims entered:

- Start with a small number, such as 20
- Once you've verified that they were sent, increase the number to 50
- Continue to increase the number as you get a feel for how long the transmission takes
- No matter how fast the transmission is, be careful not to 'over-do' it. Beta testing revealed that most sites' systems could handle a maximum of 200 claims at a time. Sending more claims than your system can handle could result in a system crash.

As the backlog of deferred claims is submitted, the numbers displayed in the REST option will change. Keep in mind this process will take some time for you to get through, depending on the number of deferred claims in your system and how fast your system is able to transmit.

# Federal Locations, please share the following information with the business office:

UFMS has a file size limit of 20,000 records per file. Keep in mind that the payable responses for these claim submissions are creating bill entries in the Third Party Billing and Accounts Receivable applications. Please keep an eye on the total number of records in all of the un-transmitted cashiering sessions and be sure to export to UFMS before you exceed the file size limit. Files that exceed the size limit will be rejected by UFMS.

### 2.3 Troubleshooting Tips

#### MGR 'Statistics & misc. options screen' is Stuck

Step 1-If the process displayed in the MGR option doesn't start moving, use the ZERO option located on the Pharmacy POS Manager menu to reset to queue (Pharmacy POS Manager Menu > MGR > ZERO). After the ZERO option has been run, check the MGR option again to see if the process is running. If it is, proceed to Step 2 above to begin submitting the backlog.

Step 2-If the process still isn't running, contact your local IT/site manager for assistance and ask him/her to refer to the patch Notes file for technical guidance. If the guidance provided in the Notes files doesn't resolve the issue with the MGR option being stuck, please open a Helpdesk ticket for assistance from the OIT Pharmacy Point of Sale team.

#### ELIG / PRIV / TEST Options Disabled

As mentioned in the Summary of Changes, this patch does not allow for sending patient eligibility checks to Change Healthcare via the ELIG and PRIV options, nor does it allow for submitting a test claim via the TEST option. Those options will be re-enabled in the next ABSP patch. Patch 53 disables these options to prevent users from accessing them and causing programming errors to populate in the error trap.

Returned to Stock claims mark the A/R Bill as cancelled and place the bill on the A/R Cancelled Bills Report (A/R > MAN > RPT > CXL). Please advise the business office that there will be cleanup required on their end as well.
