Dear Arizona Tribal Leader:

On November 20, 2018, I initiated a Tribal Consultation to seek your comments and recommendations on the implications and feasibility of having the entire State of Arizona designated as a Purchased/Referred Care Delivery Area (PRCDA).

As indicated in the letter, the IHS held a face-to-face Tribal Consultation at the Phoenix Area Tribal Budget Formulation Meeting on November 27, 2018. We also hosted a subsequent conference call on December 19, 2018. In acknowledgement of the partial government shutdown and requests by Tribes and Tribal Organizations for additional time to provide consultation and comment on this matter, I am extending the comment submission deadline for this Tribal Consultation until **Wednesday, May 15, 2019**.
