

- What CFPM trends are we seeing in the field?
 - Increase in CFPM deficiencies last year but this year DEHS staff offering ServSafe training
- What are barriers to achieving the Performance Measures?
 - A lot of FSS staff certificates expiring
 - Turnover of employees at establishments
 - Low pass rate
- What novel approaches are being used to increase the number of CFPMs in the Areas?
 - Offering ServSafe training
 - Ensuring DEHS staff have the tools they need to provide training
 - Impress upon food establishments the importance of having certification
 - Low pass rate: DEHS staff work with those individuals as best we can
 - o Is online/virtual training an option?
 - Can EHSC provide courses?
 - Partner with tribal *enforcement* partner for them to help "require" the certification
 - Can DEHS or EHSC offer a scholarship for those who cannot pay for the course?
