## LONG-TERM CARE JOINT VENTURE CONSTRUCTION PROGRAM PHASE I-APPLICATION KIT INFORMATION

Thank you for your interest in the Joint Venture Construction Program (JVCP). This is a historic occasion for the JVCP. During this application cycle, IHS invites tribes to apply for a LONG TERM CARE (LTC)<sup>1</sup> JVCP facility. A JVCP project includes acquiring, constructing, or renovating an LTC, including a Skilled Nursing Facility and a Long-term Home.

Enclosed is a complete application kit for the Indian Health Service (IHS) LTC JVCP. The selection of projects to participate in the LTC JVCP involves (1) a two-part application phase, (2) the preparation and submission of planning documents for IHS approval, and (3) the negotiation and execution of a JVCP agreement. This phase I-application kit contains four sections: (I) Program Announcement, (II) Selection Process, (III) Application Review Process, and (IV) Application Checklist.

The Phase I-Application will be used to determine if the proposed project is eligible for consideration and has the potential for successful competitive selection. The applicants will use the final application to provide documentation of their administrative and financial capabilities to accomplish the proposed LTC JVCP project.

To be considered, applicants may submit the complete application, with all attachments electronically or in hard copy, by the **CLOSE OF BUSINESS on <u>April 10, 2025</u>.** The **Phase I application** will be **submitted to** the **IHS Area with jurisdiction over** the proposed project (see **APPENDIX I**).

For hard copy submissions (original plus one copy), mark envelopes "FY 2025 LONG TERM CARE JVCP PHASE-IAPPLICATION." It is recommended that applicants obtain proof of delivery, as IHS will not consider late submittals.

For electronic submission (**Preferred method**): Send the signed original (PDF files only) to the **IHS Area having jurisdiction**. Include the following in the subject line: "FY 2025 LONG TERM CARE JVCP PHASE-I APPLICATION". Separate emails if submitting more than one application.

**RESPONSIBLE OFFICE:** Division of Facilities Planning and Construction, Office of Environmental Health and Engineering, Indian Health Service (IHS), Department of Health and Human Services (IHS).

**PROGRAM TITLE:** (LONG TERM CARE JOINT VENTURE CONSTRUCTION PROGRAM), Fiscal Year 2025

<u>PURPOSE OF PROGRAM</u>: Under the LTC JVCP, federally recognized American Indian and Alaska Native Tribes construct a Tribal-owned Long Term Care, Skilled Nursing Facility, or Long-term Home facility using non-IHS funds that meets IHS design criteria and approval. In exchange, IHS will enter into a 20-year nominal lease for the facility and request annual appropriations for the operation and maintenance of the facility during the lease period. Additional priority is to be given to Tribes who agree to fund the initial equipment portion of the project.

<u>PURPOSE OF ANNOUNCEMENT</u>: Announces the IHS Fiscal Year 2025 JVCP application period and the Application Kit for interested Tribes. Responding to ongoing Tribal interest and continuing Congressional program support, the IHS is initiating solicitation for new LTC JVCP projects to participants in the program. **This will be a Demonstration Project requiring approved metrics for measuring performance.** 

NUMBER OF PROJECTS ANTICIPATED FOR SELECTION: To be determined.

**SUMMARY:** The IHS is announcing the LTC JVCP Solicitation in December 2024.

This Program Announcement (PA) consists of four parts:

- Part I-PROGRAM DESCRIPTION provides the program's statutory authority, describes what is authorized, provides the conditions of the authorizing legislation, and identifies the program concepts and competitive selection process.
- Part II-APPLICATION PHASE describes the Phase I-application phase and tentative Program Schedule.
- Part III- EVALUATION CRITERIA FOR APPLICATIONS provides information about how the Final Applications will be evaluated.
- Part IV-PROJECT SELECTION describes the completion of the prioritization process. All necessary application forms are to be completed by the applicant following the LTC Application Kit instructions.

<u>APPLICATION KITS</u>: LTC Application Kits will be available for distribution in December 2024. <u>APPLICATION DEADLINE DATES</u>: Phase I-Applications in response to this PA will be submitted to the local IHS Area Office by the close of business on April 10, 2025.

<u>APPLICATION RECEIPT POINT</u>: Phase I-applications and the corresponding Final Applications are to be **sent to the respective IHS Area that has jurisdiction** for the proposed project. #### PART I - PROGRAM INFORMATION - JOINT VENTURE CONSTRUCTION PROGRAM (JVCP)

Pursuant to all authorizing legislation, the IHS JVCP is being implemented as described below.

#### A. STATUTORY AUTHORITY<sup>2</sup>

The JVCP's statutory authority is contained in the Indian Health Care Improvement Act, Title III, Section 818(e), P.L. 94-437, as amended and as codified and implemented by 18 USC 1636h(e).

#### **B. AUTHORIZATION**

The IHS, under the JVCP, is authorized to establish projects where American Indian and Alaska Native (AI/AN) Tribes or Tribal Organizations can construct or acquire a Tribally owned LTC health care facility in exchange for the IHS providing the initial equipment, then operating and maintaining the LTC health care facility for 20 years under a no-cost lease. Additional priority is to be given to Tribes who agree to fund the initial equipment portion of the project.

#### C. CONDITIONS OF PARTICIPATION

The Tribe must:

- Show the administrative and financial capabilities required to complete the facility in a timely manner;
- Must expend Tribal, private, or other available non-IHS funds to complete the facility; and
- Lease the Tribally-owned health care facility to the IHS for 20 years under a no-cost Government lease.

In return, during the 20-year lease period, the IHS will:

- Include funding for supplies, staffing, operation, and maintenance of the health care facility in the annual appropriation request;
- Provide the initial equipment for the facility if agreed to in the application process; and
- Request initial appropriations from Congress for an aggregate total, over one or more years, of <u>85 percent</u> of the projected total staffing need, at beneficial occupancy minus the existing staff, as determined using IHS Resource Requirements Methodology Needs Assessment (RRMNA) Criteria<sup>3</sup> and the IHS-approved User Population data. The **IHS makes no guarantee of when the requested resources will be appropriated. Also note that staffing in advance of the facility lease date will not be approved.**

If a Tribe breaches or terminates without cause, a Joint Venture Agreement (JVA) will be liable to the U.S. Government for the amount paid by the Government.

#### D. JVCP PROGRAM CONCEPTS

- **INITIAL ELIGIBILITY:** All Federally recognized Tribes planning to construct or acquire an inpatient or outpatient health care facility are eligible; see Appendix II. This includes:
  - o Direct Services Tribes
  - o Title I or V Tribes
  - Tribal Organizations
  - o All other Federally Recognized Tribes
  - o Projects already listed in the IHS Construction Priority System
- **FUNDING PLANS:** In accordance with the JVA entered into by IHS and Tribes and/or Tribal Organizations, the construction schedule and the projected facility completion dates, IHS will request appropriations for additional staffing and operations of the leased health care facility. The IHS staffing and operations funding **is not to be used as collateral** in obtaining funding for facility construction.
- **ACQUISITION:** The health care facility acquired pursuant to the JVCP may be through new construction, renovation of an existing facility, or the acquisition and renovation of another suitable facility.
- **PROJECT PRIORITY:** Priority is to be given to Tribes that currently have no existing federally-owned health care facility or have a facility listed in the IHS Health Care Facilities Construction priority system. Additional priority is to be given to Tribes who agree to fund the equipment portion of the project.
- NO RETROACTIVE PROJECTS: Facilities already acquired by a Tribe will not be considered retroactively. A project will be disqualified if a Notice to Proceed with construction is issued prior to an executed JVA between the IHS and Tribe.
- **TRIBAL ABILITIES:** The Tribe must demonstrate to the IHS their capacity to manage and fund the construction of the proposed project in a timely manner.
- **CONFORMANCE WITH IHS AREA MASTER HEALTH PLAN:** The proposed project is to be consistent with applicable Area Health Services-Facilities Master Plans.
- PJD AND POR REQUIREMENTS: All LTC JVCP Projects are required to use the planning criteria specified in the IHS health facilities planning process. These include a Program Justification Document (PJD), a Program of Requirements (POR), a combined Phases I and II Site Selection and Evaluation Report, which includes full compliance with National Environmental Policy Act (NEPA) requirements, and a cost estimate. The projected workload must be validated by the IHS data system. The IHS supported staffing requirements will be determined in accordance with the IHS Resource Requirements Methodology (RRM). The approved PJD/POR will be the basis for providing the initial equipment funding and approved space and requesting appropriations as required for additional staffing and operation of the health care facility under the lease.

#### Section I – Program Announcement LTC

- STAFF QUARTERS: A Tribe may be required to demonstrate that adequate staff housing is available for the proposed required staff. IHS may request a Housing Verification Study Report<sup>4</sup> (HVSR) be completed if adequate housing is not documented in the PJD. All staff quarters approved in the planning documents are to be constructed and are to be available for use when the health care facility is ready for operation. The Tribe will be the owner of the staff quarters and responsible for all costs for their construction and subsequent operation and maintenance, and IHS funding may not be used for the quarters construction. Once complete, staff quarters will be self-supporting from revenues generated from the rental fees.
- **SUSTAINABILITY:** All JVCP facilities will comply with all requirements of the IHS Technical Handbook Chapter 33 "Leasing" <a href="https://www.ihs.gov/oehe/handbook/volume4/">https://www.ihs.gov/oehe/handbook/volume4/</a>.

#### E. SELECTION AND APPROVAL PROCESS

The selection of projects to participate in the IHS LTC Joint Venture Construction Program (JVCP) involves (1) a Phase I-Application phase, (2) a Final Application phase, (3) the preparation and submission of planning documents for IHS Headquarters approval, and (4) the negotiation and execution of a JVA.

#### PART II - APPLICATION/SELECTION PHASE

There are two steps in the application/selection phase.

#### A. PHASE I-APPLICATION

The Phase I application will be used to determine if the proposed project is eligible and competitive for selection. Those Tribes with the top-ranking projects will be requested to submit Final Applications.

#### **B. FINAL APPLICATION**

In the Final Application Phase, the applicant will submit documentation of their administrative and financial capabilities to accomplish the proposed LTC JVCP project. Selected projects from the Final Application phase will be rank-ordered, and project start notifications will commence.

Note: Applicants failing to submit Planning Documents by the due date will be considered non-responsive and be disqualified for the LTC JVCP and IHS will proceed to the next-highest ranked project. The Site Selection and Evaluation Process (SSER) Final Phase approval by IHS Area includes NEPA approval. If an Environmental Assessment (EA) is required and is not complete, the Applicant must include all environmental compliance documentation completed to date and state when the EA is expected to be approved.

#### PART III - EVALUATION CRITERIA FOR APPLICATIONS

#### A. PHASE I-APPLICATION

The Phase I-Application submittals will be reviewed by IHS for compliance with the eligibility requirements as outlined in this document. Using the scores recorded in **Table I**, **Phase I 2025 LTC JVCP Evaluation Criteria and Weighting Form**, a rank order will be established for the Phase I-Applications received, and the top-ranked applicants will be invited to submit Final Applications for consideration.

#### Section I – Program Announcement LTC

#### **B. FINAL APPLICATION**

A panel comprised of Tribal, IHS employees, federal agency employees, Healthcare and Construction industry peers, and Tribal Health Organization employees, an all-volunteer group will comprise the Objective Review Team (ORT). The team will evaluate and rate all of the Final Applications using established rating criteria in the **Final Phase**. **The applications will be rated on (1) relative need, (2) ability to fund project, (3) ability to manage project, and (4) ability to complete project on schedule.** 

#### **PART IV - PROJECT SELECTION**

Successful final applications will be prioritized as outlined in Section I, Part III.B above. As program capacity becomes available, applicants on the LTC JVCP priority list will then be invited to commence the next phase, which includes the development and completion of the planning documents.

#### PHASE I-APPLICATION

The Phase I-Application is to be prepared by the eligible federally recognized Indian Tribe. Each IHS Area has a JVCP Point of Contact (POC) available to assist the applicant with preparing the Phase I-Application. The list of IHS Area POCs is in Appendix I.

The Phase I-Application is to be submitted to the IHS Area Office having jurisdiction for the proposed project. The Phase I-Application is due to the IHS Area Office no later than April 10, 2025. See the Program Announcement in Section I for details. Electronic submission (PDF) is the preferred method.

The IHS Area Office is responsible for reviewing and validating the Phase I application prior to forwarding it to IHS Headquarters in Rockville, MD. It is highly recommended that the applicant contact the respective IHS Area Office to verify eligible **2035 projected User Populations** and Service Areas before finalizing their Phase I application to avoid delays or disapproval of the Phase I application.

The Phase I-Application is to contain, at a minimum, the following identified elements and is to be assembled in the order shown below:

- 1. Phase I-Application Cover Sheet. The cover sheet is to identify that the document is a Phase I-Application for the LTC Joint Venture Construction Program, show the name of the applying Tribe (use the name listed in Appendix II, Indian Entities Recognized and Eligible to Receive Services from the United States Bureau of Indian Affairs), and reflect the submission date. See Exhibit I for a sample.
- 2. **Signature Sheet:** A signature sheet is to be signed by the Tribal leader for the proposed project. This sheet is to be signed also by the applicable IHS Area Director, recommending consideration. See Exhibit II for a sample.
- 3. **Table of Contents.** All pages of the Phase I-Application are to be numbered. The Table of Contents is to list all sections in the Phase I-Application, with the corresponding starting page numbers.
- 4. **Project Summary:** The proposed project's two-page summary of "who, what, when, where, how, and cost," including the project's short- and long-term objectives, is to be provided.
- 5. **Federally Recognized Tribe Documentation:** Documentary proof that the applicant is a Federally recognized Indian Tribe or Tribal organization will be provided. This can be documented by providing a copy of the applicable page from the Federal Register that provides the Department of Interior, Bureau of Indian Affairs, Indian Notice, entitled "Indian Entities Recognized and Eligible to Receive Services from the United States Bureau of Indian Affairs," with the name of the applying Tribe circled and/or highlighted. (The latest Federal Register edition is Volume 89, Number 5, dated Monday, January 8, 2024 / Notices -- 88 FR 54654, and is included in Appendix II)
- 6. **Tribal Commitment:** A signed Tribal Resolution certifying the Tribe's commitment to participate in the JVCP, with the project identified therein, is to be included. Any later significant deviation from this resolution will negate the project's participation in the LTC JVCP.

The LTC JVCP evaluation occurs in two phases, the first phase or Phase I has five criteria (Facility Resource Deficiency, Health Status, Isolation to Service, Facility Size, and Tribe Funding Equipment) and the second phase or Final Phase has three criteria (Ability to fund the project, Ability to manage the project, and Ability to complete the project on schedule).

The process for Phase 1 begins with the IHS Area validating that the proposal is consistent with the applicable Area Health Services-Facilities Master Plan.

**Table I Phase I 2025 LTC JVCP Evaluation Criteria and Weighting Form**. The score calculated in Table 1 uses the HFCPS Process and is the phase I score. The Phase I-Applications are then ranked by those scores.

The highest-scoring applicants from Phase I are selected to apply for the Final Phase review for potential 2025 LTC JVCP awards<sup>6</sup>.

The Final Phase applications are evaluated by an Objective Review Team (ORT). The Final Phase score is calculated as follows: the Phase I score is multiplied by 40 percent, with additional points added based on the following criteria:

- the ability to fund the project: up to 300 points;
- the ability to manage the project: up to 200 points; and
- the ability to complete the project on schedule: up to 100 points.

These three criteria total 600 points and will be determined by the ORT and summed for a maximum possible score of 960 for the Final Phase total score.

The IHS Headquarters (IHS HQ) leadership review team will determine those proposals that receive an award for the LTC JVCP<sup>6</sup>.

## INSTRUCTIONS FOR THE INDIAN HEALTH SERVICE JOINT VENTURE CONSTRUCTION PROGRAM Explaining Table 1, Phase I 2025 LTC JVCP Evaluation Criteria and Weighting Form

#### 1) The Facility Resources Deficiency Criterion

Table 1 on page 19 Evaluation Criteria 1 is the Facility Resource Deficiency Criteria Factor. Tables 2 through 4 are used to determine this factor.

- References cite that between 50 and 70% of individuals over 65 will need some type of Long-Term Care services and that 25 to 33% will require care in a Long-Term Care Facility. The breakdown specific to AI/AN is difficult to determine as historic utilization data for this population is not available. One study from Health Affairs, 2015, listed Annual Utilization Rates per 10,000 people ages 65 and older. AI/AN were listed under Non-Hispanic Other.
- Using this data, 25% of individuals at risk (user population >65) would potentially need LTC inpatient care. Therefore, a tribe or combination of tribes would need a minimum of 120 individuals >65 to justify a 30-bed LTH facility. The minimum total active user population would depend on the age distribution and percentage of individuals over 65 in relation to the entire tribal population. Census data shows the number of AI/AN over the age of 65 is expected to increase by 46% through the year 2060 along with the rest of the population, so the need for Long Term Care alternatives for AI/AN will continue to increase.
- o Using a starting point of 25% greater than 65 years of age of the current user population to determine existing facility resource deficiency
- o The existing facility age adjustment factor is calculated using Table 4.

If a proposal receives an award, the constructed facility size will be based on an approved Program Justification Document (PJD), Program of Requirements Document (POR), and the Joint Venture Agreement and Lease (JVAL).

For an existing facility, the age factor is used to calculate the "Adjusted Existing Space" for a facility. These data are obtained from the IHS Healthcare Facilities Data System (HFDS) database. Tribes not participating in the IHS HFDS database must provide this data with documentation verified by a licensed professional (engineer, architect, etc.) If there is a significant difference between the data used during Phase I and the data validated during the Final Phase, a facility could be disqualified from the Final Phase.

#### 3) Isolation Criterion

The Isolation Criterion provides an advantage to those facilities where the population is geographically isolated and does not have access to nearby LTC. It refers specifically to the amount of time it takes most people to get to a place where they can receive healthcare services. In the HFCPS, time is estimated using the distance from the Indian health facility or proposed facility to the nearest Medicare and Medicaid-certified LTC Facility. (Federal, Tribal, or private sector). Facilities not on a road connecting to a Federal or State highway are assumed to be isolated. Table 6, "Calculating Isolation," illustrates how the Isolation Criterion value is calculated:

The distance from the Indian health facility or proposed facility to the nearest Medicare and Medicaid certified Long Term Care Facility with availability can be determined by the applicant using any means determined by the applicant.

#### 4) Facility Size Criterion

The Facility Size Criterion increases the total Priority Score for smaller facilities. Facilities serving smaller populations receive up to 150 points, while facilities serving larger populations receive proportionally fewer points. The Facility Size Criterion is based on the IHS User Population for the Facility Service Area. This information is obtained from the IHS National Patient Information Reporting System (NPIRS) and can be found at <a href="https://hsp.ihs.gov/index.cfm">https://hsp.ihs.gov/index.cfm</a>, the HSP website. The Facility Size Criterion is calculated using the formulas in Table 7. The formulas provide the Facility bed Size Criterion factor for facilities. The Facility bed Size refers to the required beds; which is based on the user population for all facilities. The Required # of bed formula is found in Table 2, Phase I Required Space Formula.

For each facility considered, the HFCPS Formula incorporates the weighting for each factor and sums the factors to obtain the score (see **Table 1**, **Phase 1 2025 LTC JVCP Evaluation Criteria and Weighting Form**).

In Phase I, only the Relative Need Score and Equipment Funding Score are summed for a Maximum Possible Score of 900.

In Final Phase, these factors, as well as the ability to fund, manage, and complete the project on a schedule determined by the ORT, are summed for a maximum possible score of 960.

**Table 1, Phase 1 2025 LTC JVCP Evaluation Criteria and Weighting Form** shows the weightings and how the factors are summed in Phase I.

#### A) Phase I

#### 1. Time Line

The IHS will run Phase I during the JVCP's Phase I application. Implementation of Phase I should take approximately three months. See the tentative schedule.

#### 2. Facilities Evaluated in Phase I

During Phase I -application evaluations of the LTC JVCP proposals, every LTC JVCP proposal will be reviewed and ranked according to the Phase I evaluation criteria.

#### 3. Data Used LTC JVCP Phase I

The data required for completion of Phase I are:

- User population from the IHS National Patient Information Reporting System or similar methodology;
- Existing facility size, and age from the IHS Facility Data System or verified by a licensed professional (engineer, architect, etc.),
- Death Rate, All Causes of Death,
- The distance from the proposed facility to the nearest certified similar Long Term Care Facility with availability.
- Facility Size Criterion,
- Facility equipment funding contribution.

#### 4. Validation

Phase I data will be validated by the Area and confirmed by IHS-HQ DFPC.

#### 5. Scoring

The Phase I-Application submittals will be reviewed by IHS for compliance with the eligibility requirements as outlined in this document. Using the scores recorded in **Table 1**, **Phase I LTC 2025 JVCP Evaluation Criteria and Weighting Form**, a rank order will be established for the Phase I-Applications received, and the top-ranked applicants will be invited to submit Final Applications for consideration according to the score received.

#### 6. Uses of Scoring

The Phase I scoring will be used to identify LTC JVCP proposals for review in the Final Phase.

#### 7. Final Phase Time Line

The IHS anticipates running the final Phase of the 2025 JVCP in 2025. The exact dates are listed in the tentative schedule on page 11.

#### 8. Facilities Evaluated in Final Phase

The number and type of facilities evaluated in the Final Phase will depend on the budget available. Before a facility may be considered in the Final Phase of the LTC Joint Venture Program, a Tribe must show a capability and willingness to enter into an agreement with the IHS. Under the JVCP agreement, the Tribe will acquire the facility and lease it to the IHS at no cost for 20 years; in return, the IHS will equip the facility and provide resources for its staffing and operation.

#### PREPARATION AND ASSEMBLING

The Phase I-Application is to be prepared in the English language. To facilitate review, validation and selection, prepare and submit the application conforming to the below requirements:

- c. All four border margins are to be one inch.

#### **Phase I-APPLICATION REVIEW**

The Phase application will be reviewed for compliance with the requirements in Sections I and II. A rank order will be established for the Phase applications received using the scores of the LTC JVCP using Table 1, Phase 1 2025 LTC JVCP Evaluation Criteria and Weighting Form. After all the proposals received are reviewed and validated, and the scores are checked, the Indian Health Service Headquarters' review team will determine the number of LTC Joint Venture Proposals that will be invited to prepare and submit Final Applications as outlined in the schedule page 11 and the Final Application Kit. The proposals that will be invited to submit Final Applications will receive an invitation letter and a link to the Final Application Kit.

#### LATE APPLICATION

Each part of the application will be considered to be "on time" if it is:

- a. Received by the applicable IHS Area on or before the established deadline date; or,
- b. Sent with a legible U.S. Postal Service mark dated on or before the deadline date. Private metered mail postmarks will **not** be accepted as proof of timely mailing. A late application will **not** be accepted.

#### NONCONFORMING APPLICATION

Nonconforming applications will not be accepted. An application is nonconforming if it does not meet the requirements of the Program Announcement and the submission requirements in this Phase I-Application Kit or Final Phase Application Kit.
