I am writing to provide advance notice of four upcoming information sessions we will convene in Calendar Year 2025 to continue our discussion of the Indian Health Service (IHS) Health Information Technology (HIT) Modernization Program. In conjunction with ongoing Agency outreach, we will also be seeking your recommendations and feedback via Tribal Consultation and Urban Confer on these topics.

Please "Save the Date" and make plans to join us at these important and timely meetings. Your participation and input to date have been vital to improving the Health IT Modernization Program.

During each of these information sessions, the IHS will provide an update of our progress, milestones, and program challenges.

- The information session scheduled for **February 13, 2025**, will provide an opportunity for Tribal Leaders, Urban Indian Organization Leaders, and their designated representatives to join breakout sessions with IHS Health IT Modernization Program leadership.
- The information session scheduled for **May 15, 2025**, will feature an overview of the Four Directions Warehouse, which is the data repository that will be used to facilitate the migration of data from the IHS Resource and Patient Management System and other electronic health record (EHR) solutions into PATH EHR, and allow for continued access to legacy patient data.
- The information session scheduled for **August 7**, **2025**, will feature an overview of applications to be included in PATH EHR based on outcomes from enterprise configuration workshops.
- During the information session on **November 6**, **2025**, Health IT Modernization Program leadership will review the status of pilot site activities and upcoming milestones for PATH EHR implementation at facilities located within the Lawton Service Unit in the Oklahoma City Area IHS.

Each information session will be delivered virtually, via Zoom. We are asking that attendees register in advance for the sessions through the links provided in the enclosure, "IHS Calendar Year 2025 Health Information Technology Modernization Tribal Consultation and Urban Confer Sessions."
