the American Board of Family Medicine who has worked with the Indian Health Service for 13 years. She is an enrolled member of the Confederated Tribes of the Goshute Reservation located on the border of Utah and Nevada.



CAPT Cynthia Gunderson, PharmD, IHS HOPE Committee Chair, is a United States Public Health Service Pharmacist with the Indian Health Service (IHS). She is a 2004 graduate of the University of Nebraska Medical Center College of Pharmacy. CAPT Gunderson serves as the Chair of the IHS National Committee on Heroin, Opioids, and Pain Efforts (HOPE Committee) and Director of Revenue Enhancement for the Bemidji Area. In these dual roles, CAPT Gunderson works with diverse, interdisciplinary teams to identify opportunities for

improvement, to engage key stakeholders, and to achieve success.
