ONC Certified Health IT – Certified RPMS/EHR

SVAP Notice, June 2024

This is a Standards Version Advancement Process (SVAP) advance notification to IHS partners for the IHS RPMS/EHR Health IT, **no action is required**. This is information only in advance of IHS RPMS/EHR releases supporting the ONC Certified Resource Patient Management System Electronic Health Record.

The Standards Version Advancement Process (SVAP) permits health IT developers to voluntarily update Health IT products certified under the ONC Health IT Certification Program to newer versions of adopted standards as part of the "Real World Testing" Condition and Maintenance of Certification requirement (§170.405) of the 21st Century Cures Act.

- Using SVAP, certified health IT developers can voluntarily use a newer approved version of a standard than what is adopted in regulation.
- Currently, this flexibility is limited to standards that are adopted in the certification criteria required to meet the "Real World Testing" Conditions of Certification, which includes §170.315(b), (c)(1) through (c)(3), (e)(1), (f), (g)(7) through (g)(10), and (h).
- Health IT developers taking advantage of the SVAP flexibility must ensure that their Real World Testing
 plans and results of the certified health IT modules address these updated standards.
- Additionally, health IT developers updating their already certified health IT modules are required to
 provide advance notice to their clients and the ONC-Authorized Certification Body (ONC-ACB) before
 adopting a newer approved version of a standard.

Advance notice for specific ONC Certified Health IT Certification can include criteria §170.315(b), **(c)(1) through (c)(3)**, **(e)(1)**, **(f)**, **(g)(7) through (g)(10)** in support of the IHS Certified RPMS/EHR product and mandatory SVAP updates. With the SVAP, IHS will update our eCQM certification for the RPMS/EHR Certified Health IT. The finalized 2023 SVAP includes updated QRDA implementation guides from CMS as the next standard for vendors to voluntarily promote SVAP with advance notification.

For the QRDA updates, IHS RPMS/EHR partners should not expect changes to the standard annual submissions currently in place. Updating to the newest version of QRDA categories I and III is a required step to submit Quality Reporting for the Quality Payment Program (QPP) to CMS attestation.
